# **Role description**

### **Role context**

We are the organisers of two world-leading international congresses that support this mission, entitled Healthy City Design and European Healthcare Design.

A new position has arisen for an ambitious research associate seeking an opportunity to:

- Work on projects addressing the urgent issues of population and planetary health
- Work at the forefront of the emerging and exciting field of healthy city design
- Work on 'live' projects translating research into practice
- Collaborate with a network of leading UK and international experts in the field
- Make an impact at the intersection of research, practice and policy
- Build digital media, communication and stakeholder engagement skills
- Grow a professional and research network

### **Role purpose**

The Research Associate will play a critical role in driving the organisation's vision across all of its media, events and research activities, working directly with a small and experienced management team and a wider network of international advisors and consultants.

In the next 18 months, a significant part of the role will contribute to a commissioned international project to inform the future development of a major new settlement. The work includes the development of reports to the end client on how to implement evidence-based approaches in the design of a community that supports healthy and sustainable living at an international standard. The role will also:

a) support the programme development and delivery of two international congresses and associated webinar programmes

b) support the programme delivery of two international awards programmes

b) support editorial, digital media and book publishing activities

# **Principal duties**

The following duties outline the principal duties but are non-exclusive.

**Knowledge management:** To contribute and support the administrative and commercial development of SALUS' knowledge base/asset, promoting and developing the value to its global network

**Project based Research:** Includes internal research and knowledge management, and externally commissioned research; as well as undertaking basic research, including design and planning of literature reviews and synthesis of evidence for a range of audiences

**Project and task planning:** To deliver projects on schedule through advanced project management, administrative and problem-solving skills, combined with exemplary attention to detail.

**Communication:** To provide project brief development, editorial and report writing, oral presentations and potentially webinar chairing/hosting, requiring strong personal written and oral communication and engagement skills, with the ability to communicate challenging concepts and ideas effectively with an understanding of both the research and the commercial context.

**Teamwork:** To contribute towards a team ethos within a dynamic, multi-disciplinary, deadlinedriven environment, typically working remotely with both the internal management team and staff, and external advisors and consultants.

**Networking (internal & external):** Contributing to the development of the SALUS global community through the development of strong relationships with researchers, practitioners and policy thinkers.

# **Person Specification**

#### Essential:

- Masters level qualification in a public health and/or built/natural environment discipline (including but not limited to environmental health, public health, urban design, landscape design, architecture, town planning)
- A clear understanding of the links between population health, planetary health and the natural, social and built environment
- Strong communication and problem-solving skills and commitment to the SALUS vision

#### Desirable:

- Working toward or has completed a PhD
- Experience of working in a commercial practice (eg. architect, urban planning, real estate) or/and a public sector organisation (eg local authority/public health).
- Qualification includes or is specifically related to healthy urban design

# Skills, knowledge and experience

**Critical skill range:** As appropriate to the level of this role. Skills may be demonstrated through a mix of qualifications, professional experience or relevant personal pursuits/activities.

- An interest in and knowledge of the field of healthy urban planning and design
- Planning, implementing, and executing research.
- Research design, inc. question design using appropriate methods, protocols, and techniques.
- Executing research including analysis.
- Writing academic research outputs.
- Writing skills to include: initial drafting, review, and finalising outputs including working with team members (both internal and external) to integrate changes.
- Demonstrated commitment to continuous learning and updating knowledge and understanding in area of specialism.
- Good communication skills: written outputs, academic groups, practice / industry groups; experience presenting/chairing at conferences / events / webinars
- Commitment to building own network and contacts.
- Social media: demonstrated confidence in use of various social media platforms.
- Is self-motivated, can manage own time and workload. Can work to a deadline.
- Technology: confident user of digital technology and associated software packages including Microsoft Office.
- Reference management: knowledge of reference management software & data management, for example, Mendeley / EndNote / Zotero or equivalent.
- Literature sources & management: skilled at identifying suitable and relevant literature sources and interrogating these as part of literature review and synthesis. For example, familiarity with Scopus, Web of Science, Cochrane Library, or equivalent.
- A commitment to ongoing learning and personal development.

#### Desirable:

- Quality & Risk of Bias: an understanding of quality of evidence in relation to producing outputs for various audiences.
- Writing practice & industry reports.
- Publishing and editing experience (books, magazines, journals)
- Public speaking or chairing at professional conferences/events
